### Region Events

#### 2024–25 State Singles Qualifiers start from the 6<sup>th</sup> July 2024.

#### Important Information for All Players:-

- Players should be familiar with the 2024–25 Conditions of Play.
- Players need to be aware that a lot of the Round 2 games are being played in the Round 1 Timeslot so they need to pay extra attention to the time allocated to their game.
- Most players that have byes in the first round will be required to mark (a list of the players required to mark in the first round have been supplied to all clubs).
- All players need to be aware of their responsibilities as markers and especially aware of Bowls NSW 24–25 COP 1.27.1 Penalty (failure to mark if required).

The Women's Pennant submission has been sent to Bowls NSW (start date Tuesday 20<sup>th</sup> August 2024). Once approval has been received, and the draw has been finalised, all clubs will be notified.
